# **Expression of Interest:** Development Consultant

Specialist in Program Quality, Learning Systems, and Organisational Accreditation Readiness

#### 1. Background and Context

SeeBeyondBorders Australia (SBB Australia) has as its primary focus the systemic improvement of teaching and learning in Cambodian government primary schools. The organisation has had base level Department of Foreign Affairs and Trade (DFAT) Australian NGO Cooperation Program (ANCP) accreditation since 2017, and will apply for full accreditation in mid 2026. Until January 2025, SBB Australia's programs in Cambodia were implemented through its Cambodian office, so the recipient of ANCP funding and the implementer of funded interventions were one and the same. This year, the Cambodian implementing arm of SBB Australia became a locally-registered organisation, StudyBeyondBorders (SBB Cambodia) and is now the Implementing Partner of SBB Australia.

As the Australian NGO that is the funding recipient, SBB Australia must demonstrate compliance with all requirements for full accreditation. However, Section B – Development Approaches and Management, largely relates to the responsibilities of the Implementing Partner, SBB Cambodia. Hence it is essential to ensure the organisational systems of both entities meet the standards outlined in the ANCP Accreditation Criteria and the Australian Council For International Development (ACFID) Quality Assurance Framework. The consultant will work collaboratively with StudyBeyondBorders Cambodia (SBB Cambodia), the organisation's Implementing Partner in Cambodia, to ensure that local operational realities and perspectives are fully documented and are reflected in the ANCP accreditation application. They will take direction from the SBB Australia CEO-IO who is based in Siem Reap.

## 2. Purpose of the Consultancy

The consultant will carry out an in-depth review of SBB Cambodia's systems, processes and practices and their documentation, as required for Section B to establish adequacy and/or identify gaps, as the basis for providing and delivering on actionable recommendations in the preparation of evidence for ANCP accreditation. The consultant will support the strengthening of organisational learning systems and improving the alignment of internal manuals, templates, planning and mentoring tools and processes with relevant DFAT and ACFID requirements ensuring all good practice indicators can be appropriately met.

### 4. Scope of Work

In collaboration with SBB Cambodia counterparts, the consultant will undertake the following:

- Conduct a comprehensive assessment against all ANCP Section B indicators and provide actionable recommendations for each criterion.
- Review the Program Planning and Design Manual and all associated templates and develop processes and systems to ensure full alignment with DFAT ANCP and ACFID frameworks.
- Review the Program MEAL Manual and associated templates to strengthen learning, accountability, and evidence-based decision-making.
- Support consolidation of evidence for Section B accreditation, including documentation of program results, reflection processes and continuous feedback loops within SBB Cambodia and between SBB Cambodia and SBB Australia.
- Work collaboratively with SBB Cambodia to ensure findings, recommendations, and improvements reflect local program realities and capacities.
- Deliver workshops and training sessions with staff from SBB Cambodia and SBB Australia to embed continuous improvement practices.
- Prepare draft version of the Section B accreditation evidence pack for internal validation and review.
- Support revision and finalisation of the Section B evidence pack for submission.

- Experience in reviewing and developing operational manuals, templates, and program documentation.
- Strong analytical and communication skills, with demonstrated ability to synthesise evidence and recommendations.
- Experience facilitating learning and reflection processes with partner organisations.
- Commitment to child protection and safeguarding. The successful consultant must hold a valid Working With Children Check (WWCC) or equivalent police clearance before commencement.
